 - (c) Initial service of the vendor will be for 03 months and thereafter contract will be extended upto 12 months based on satisfactory service of the vendor. Further extension will be given based on the satisfactory service rendered throughout the year.
 - (c) GST No should be clearly mentioned / printed on the quotations.
 - (d) Validity of quotation should be three months and same should be mentioned on the quotation.
 - (e) <u>Payment Terms</u>. Monthly bills will only be paid by cheque to the contractor. No advance will be paid to the Contractor under any circumstances.
 - (f) Penalty for substandard wk. After completion of proj, if PMG noticed that the wk executed by the vendor has substandard, then penalty will be decided by the school management and will be maximum of 25%.
 - (g) Site of Project. To carry out the maintenance of garden area and lawn, garden pots and sports field for beautification by providing 04 x gardeners at the premises/campus at Senior Wing of the school).
 - (h) <u>Penalty</u>. In the event of failure of the successful Bidder to make the supply of the gardeners ordered within the stipulated time, without prejudice to other remedies under the supply order a penalty equivalent to 1% of the value of delayed gardeners will be levied per week with a maximum of 10% of the contract value. However, relaxations would be entertained only in special circumstances.
